## 1. PROJECT BACKGROUND

Program Implementation Unit under the Technical Assistance (TA) component of Program Support Unit, Punjab Resource Improvement and Digital Effectiveness (PRIDE) program advertised Requested for Bids (RFBs) for **providing & installation of Video Wall Solution** required for digitization of Planning & Development Board at estimated cost is **USD=518,175 (PKR 85,820,143.5)**, therefore, the procurement is processed through National Competitive Bidding (NCB) method in accordance with World Bank Procurement Regulations.

Must have previously completed supply against 05 purchase orders/contracts of similar worth. (Attach valid copies of at least 05 purchase orders/contracts of similar worth).
- iii. Must have valid registration of NTN and GST with FBR and shall be an active taxpayer or any other revenue authorities
- iv. Must be manufacturer or manufacturer's authorized partner / dealer / distributor / reseller. The bidder(s) if not manufacturer itself, must submit manufacturer's authorization on the format provided in Section IV (Bidding Forms) of the bidding documents with the bid for the quoted item they shall offer in their bid, on manufacturer's letterhead duly signed and stamped within the period of this bidding. A general authorization letter/certificate shall not be entertained.
- v. The bidders must have verifiable presence in Pakistan. Bidder has active Spare Parts Depot/ facility in Pakistan (Provide addresses, phone, fax numbers, e-mail address as well as names and designations of responsible persons for each location).
- vi. Must have annual turn of PKR=30, Million during last three years supported with financial /audited statements, bank statement / income tax returns etc. (Must be attached with the Bids).
- vii. Compliance of Technical specification of equipment
- viii. Certificate that the firm is not blacklisted by any National / International agency / Authority / World Bank / Department / Ministry etc.
- ix. Have maintenance facility/office in Lahore for after sales services,

## 6. ARITHMETIC CHECK AND CORRECTIONS

The quotations were checked for arithmetic corrections and corrections have been applied where required. The details of arithmetic corrected quotations have been summarized as following:
