## 3. SUBMISSION OF QUOTATIONS

## 4. QUOTATION OPENING

## 5. QUOTATION EVALUATION

- iv. Must be an authorized partner/dealer/distributor/reseller or contractor.
- v. Have maintenance facility/office in Lahore for after sales services.
- vi. Not be insolvent, in receivership, bankrupt or being wound up or debarred from public procurement.

## 6. ARITHMETIC CHECK AND CORRECTIONS

The quotations were checked for arithmetic corrections and corrections have been applied where required. The details of arithmetic corrected quotations have been summarized as following:
