Should have completed at least three (03) similar projects in public sector / donor funded projects of comparable scale and complexity having minimum worth equivalent to USD=40,000 (Copies of verifiable of similar nature of contracts with copies of notification of award and/or contracts and full address and contact information of the employer).
- iii. Should have sufficient HR / managerial capacity and expertise in the areas covered in the TORs. [CVs will not be evaluated at the shortlisting stage].

Interested firms must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).
