Government of Punjab, the Program Implementation Unit, Planning and Development Board, under the Technical Assistance (TA) component of Punjab Resource Improvement and Digital Effectiveness (PRIDE) program intends to hire eligible firm for "Conducting Third Party Evaluation of Process Orchestration Programming for intra-operability of CGA system with other systems". For this purpose, eligible consulting firms or association of firms (in join venture) are invited to participate in the shortlisting process (letter of incorporation of the firms will be required).

Interested Consultants (firms) should provide information demonstrating that they have the required qualifications and relevant experience to perform the subject services.

Short listing Criteria:

- i. Experience in Information Systems Design or Installation contracts in the role of prime contractor for at least the last five (5) years. Experience of implementing Human capital management (HCM) and Financial Accounting and controlling (FICO) software in Public Sectors will be preferred
- ii. Should have completed at least two (2) similar Projects where scheduled banks are integrated using SAP Process Orchestration. (Copies of verifiable of similar nature of contracts with copies of notification of award and/or contracts and full address and contact information of the employer).
- iii. Minimum average annual turnover required for the last two years is Rs. 10 Million.
- iv. Should have Key technical staff with experience of SAP integration for Electronic Fund Transfer (EFT) for at least one project. Having expertise on cybersecurity (CISP Certified Information Security Professional), with experience of implementing cybersecurity for electronic funds transfer would be preferable. The firm will be required to engage Process orchestration (PO), Advanced Business Application Programming (ABAP), Financial Accounting and controlling (FICO) and Human capital management (HCM) consultants through the duration of the evaluation.
- v. Letter of incorporation of firms will also be required.

Interested firms must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).

The attention of interested Consultants is drawn to the World Bank Procurement Regulation for IPF Borrower for Selection and Employment of Consultants on conflict of interest.

Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

Firm will be selected in accordance with the Consultant Qualification Selection (CQS) method set out in the World Bank's Procurement Regulation July 2016 (Revised November 2017 and August 2018).
