#### 1. Eligibility Criteria:

You are requested to submit copies of the following documents as evidence of your eligibility;

- a) Must have valid registration of NTN and GST with FBR and shall be an active taxpayer,
- b) Must be a manufacturer or authorized dealer having a valid certificate to this effect duly issued by the manufacturer.
- c) Have maintenance facility/office in Lahore for after sales services,

#### 2. Validity of offers

The offers shall be valid until thirty (30) days from the date of opening of the quotation.

#### 3. Preparation of Quotations

- (a) Quotation shall be evaluated on the basis of prices/eligibility of firm and the purchase order shall be issued to the firm offering the lowest evaluated price.
- (b) Your price quotation/(s) shall be for 100CC Motorcycle (2Nos) as described in attached documents. The currency of quoted prices and payment shall be Pakistan Rupee.
- (c) The prices should be quoted for supply and delivery at Lahore, Pakistan.

#### 4. Quoted Price

The quoted price will be inclusive of all applicable taxes and transportation charges at Lahore and not subject to variation.
